On August 14, 2025, A. Soriano Corporation ("Anscor") and Ayala Corporation crossed 29,239,370 common shares of iPeople, Inc. at a price of P12.00 per share via a special block sale, pursuant to the terms of the Share Purchase Agreement dated December 10, 2024. The transaction was cleared by the Philippine Competition Commission on July 29, 2025.

Post-closing, Anscor's stake in iPeople will be reduced to 6.13%.

iPeople is a holding company under House of Investments, Inc. of the Yuchengco Group of Companies and Ayala Corporation, with a focus on investments in the education sector.
